

## **Report of the Board of Selectmen**

The Board of Selectmen reorganized following the April 5 election, and Robert E. (Bob) Honohan was elected Chairman for the second time in his career. The election saw the addition of John Sylvia as our new Selectman.

The year 1976 again was very busy and productive throughout our town. There are many more problems, but we are trying to handle affairs based on need and the ability of our taxpayers to bear the expense. We are always cognizant of our people and make every attempt to guide our citizenry on a path of responsibility and accountability.

We continue to be involved with New Bedford, Dartmouth and Fairhaven in the Greater New Bedford Solid Waste and expect within the year 1977 to finalize plans at which time our people will be given the opportunity of formalizing an Agreement if they so desire. Meetings are held in New Bedford on a monthly basis.

Sewerage is still on the "backburner," but we await word from New Bedford, because we are dependent on them and the federal government. State and federal funds are available, so we hope to take advantage of this, subject to Town Meeting approval.

Southeastern Regional Transit Authority (SRTA) is providing service to our townspeople, and we have service from Lund's Corner through Fairhaven to New Bedford every 2 hours from 8:30 AM to 6:30 PM, excluding Sundays and Holidays. Service is free to Senior Citizens with proper identification card and to our handicapped.

We continue to receive Revenue Sharing, which funds the operation of the Police Department, and we are to receive Public Works Antirecessionary funds which will amount to some \$55,000 in 1½ years.

The Town Hall repairs were completed which comprised new columns at entrance, roof and gutter work, also exterior painting and a new stairway to the basement, which now meets State Building Code requirements.

The Public Stenotypist service enacted by Town Meeting vote has proved to be worthwhile, having an in-depth report that is available to the citizenry by visiting the Selectmen's Office.

We continue to be involved with federal programs, and we are proud to say we have participants on a larger scale than most area towns. We had 9 youths from ages 14 through 21 working in various departments on a 10-hour week basis after school, which is providing help to the departments and also is a financial and experience reward to those involved. The summer program of YOUTH WORK EXPERIENCE (Y.W.E.) was also of great benefit to our town, having a total of 42 youths from 14 through 21 working from July 1 to September 1 and

earning \$2.30 per hour for a 28-hour week. This was a help to all and provided additional service and valuable experience at no cost to the town.

The CETA program was highly prevalent in our town and continues. Over the past 2 years, we have had from 32 to 39 people under this program which allowed us to commence and complete many projects that would have been impossible otherwise. Our School Department was supplied with 9 people, most being teacher aides and St. Francis Xavier utilized 4 people, including 2 teacher aides. The Highway Department had 11 laborers; therefore, much needed work was completed. The total payroll for 1976 for all the CETA personnel was \$165,996.36, which was at no cost to the town. We are proud of this accomplishment which took several meetings and much extra work on the part of our Executive Secretary and his clerk.

We complied with the Mass. Growth Policy enacted by the State, and further statistics are available in our office.

Our Town Beach was greatly improved through the efforts of Selectman Sylvia and our Highway Department.

We are also thankful to SCORE of New Bedford for their help with our town's accounting system.

We were pleased to hear that Southeastern Bank & Trust has firm plans to locate in our town in 1977, which will be a most welcome asset.

Our Representative MacLean has continued to help wherever possible, which he did countless times, but a main contribution was in obtaining a Police Van with appurtenances, at no cost to the town, also that he obtained \$12,000 toward purchase of a new Ambulance to meet the new State law.

During the months of September and October, we invited INSURANCE SERVICES OFFICE to conduct an analysis of the fire defenses of the town, and hopefully in early 1977 we shall receive a favorable report, which would lower insurance premiums of our townspeople.

We have operated as frugally as possible, as we understand the financial plight of our residents. Therefore, we continue to pledge our utmost to operate as efficiently as possible.

**Gentlemen:**

To the Officers and Residents of the Town of Acushnet. I hereby submit my report for the year ending December 31, 1976. During the year members of the Police Department attended various training programs.

Acting Chief, Sgt. Roger D. Deschamps, Acting Sergeant Stephen J. Cassidy, Jr., Acting Sergeant Richard G. Langevin, Offrs. Henry C. Avila, Barry W. Monte, and Gil Marques, Jr. attended an Emergency Medial Technician/Ambulance refresher course at various locations in the surrounding area given by the Old Colony Chapter Massachusetts Association E.M.T., Inc. as required by state law.

During this year a fully-equipped Safety Van was delivered to the town, directly funded in the amount of \$13,000.00 by the Governor's Highway Safety Bureau. This van will be utilized in the formation of a safety program for the schools to educate the town's children in all phases of pedestrian safety and will also be utilized on the streets of town to promote traffic safety. Some of the equipment furnished includes radar, emergency lighting equipment, emergency generator, hydraulic rescue equipment, safety film and camera equipment.

Clerk/Dispatcher Patricia E. Dube attended a one-day seminar on Nov. 19, 1976, in Fall River on Uniform Crime reporting under the direction of the Federal Bureau of Investigation and the Comm. of Mass. Dept. of Public Safety Crime Reporting Unit.

On August 29, 1976, another full-time police officer was appointed to replace Off. Paul Dextraze, who resigned from the department.

Officers Barry W. Monte and Gil Marques, Jr. attended an instructor's refresher course given at Brockton High School under the direction of the American Heart Association, thereby, re-certifying them as instructors in Basic Cardiac Life Support.

During this year, the town also received funding from the state in the amount of \$12,000.00 for a new Modular Ambulance, which we expect before July 1, 1977.

Appointed were two more permanent full-time clerk/dispatchers to commence employment on 1/3/77 and 1/10/77.

Officers Michael Poitras and George Sylvia are presently attending the Police Training Academy being held at New Bedford for the duration of 12 weeks.

Four more men, Officers Normand H. Soucy, Michael Poitras, George L. Sylvia, and Kenneth J. Souza are now attending Emergency Medical Technician/Ambulance Training at Dartmouth. This course is to run for approximately 100 hours.

The spraying season terminated on September 16th, and our brook and ditch maintenance program got underway. This resulted in the reclamation of 2,400 feet of existing waterways and the removal of 3,666 feet of brush.

## **Report of the Conservation Commission**

All of the activities of the Conservation Commission this past year were concerned with enforcing the Wetlands Protection Act, General Law Chapter 131, Section 40. We were forced to file complaints with the Court against 2 landowners for violating this ordinance. One violation has been corrected and the case dismissed, and the second one has been continued. Violation of this law is a criminal offense punishable by a fine of \$1000 for every day of the violation or six months in jail or both. Any action we take is the result of a complaint filed by a taxpayer. This is a State law, not a local ordinance.

Since we have to use the services of the Town Counsel, the Town is burdened with the several hundred dollars in legal costs for each violation that goes to court. After conferring with the Board of Selectmen, the Commission contacted Representative MacLean, and he is introducing a bill in the Legislature to require the cities and towns to be reimbursed by the State for any legal fees involved in enforcing this Law.

We are slightly encouraged, however, as three developers have contacted us before presenting sub-division plans to the Planning Board where wetlands are involved. Only one area was rejected because of the wet condition and its effect on the surrounding property.

The United States Department of Agriculture has started the Soil Survey we contracted for in 1973, and the final work should be completed in February of this year.

After being duly elected as a member of the Board of Health at the Annual Town Election, Joseph H. Lepage was sworn into office by the Town Clerk and at the monthly meeting of the Board, the following officers were seated:

We have continued our contract with St. Luke's Hospital, New Bedford, for Homemaker-Home Aide services and are under the very competent and beneficial supervision of Mrs. Elaine Tripp, R.N., M.S., who is also Director of Community Services at St. Luke's. This program and service is available to any Acushnet resident who qualifies.

Our contract with The Easter Seal Society is still in effect, and this provides us with Physical Therapy, Speech Therapy, Occupational Therapy and Medical Social Work, which is available to all qualified residents.

In 1976 there were 8 premature births reported. Of these, 5 survived and 3 died.

The Positive reactors were then given the Mantoux Test, and 2 of the 8 reacted positively. These 2 were placed on a regimen of preventive medication by their own physicians.

MANTOUX TESTS are available to any resident who wishes to avail themselves of this service.

SPECIAL NEEDS PROGRAM for any school child needing this service continues as in the past.

WELL BABY CLINICS are held the first Wednesday of each month, excepting July and August. 287 persons attended the clinics. The following inoculations were given

BLOOD PRESSURE CLINIC was held June 19, 1976, at the two Fire Stations. A total of 148 tests were given. There were 12 recalls, of which 7 were referred to their own doctors. The Board wishes to publicly thank the Fire Dept., Board of Selectmen and each and every one of the volunteers for their services in this program.

SENIOR CITIZENS' COUNSELLING sessions have been held throughout the year. A total of 131 Seniors attended the 10 sessions.

FLU CLINIC In co-operation with the Federal Edict, we sponsored a Swine Flu Clinic and administered 844 inoculations.

HEARING A clinic was held August 19th. Sponsored by the Board of Health in conjunction with the Boston Guild for Hard of Hearing. The Mobile Unit was in Town for the day and tested 52 persons. Of those tested, 25 failed the test - these people were given a "follow-up" and referred to further diagnosis and treatment.

ENCEPHALITIS - COGGINS TESTING CLINIC, - Dr. Deane Freitas immunized 52 animals at the Gracia Farms. We are fortunate that most of the horses in Acushnet are brought to the Clinics. Others are immunized elsewhere.

STUDENT NURSE - During September, October, November and December, we hosted Miss Cynthia Polleschi of Bridgewater, a Senior Student of the S.M.U. Nursing. Miss Polleschi came into the office two days each week and learned the office, clinical and professional duties of our Nursing Service. The time spent with our Staff is credited to the Bachelor's Degree she is working towards.

North West Street was accepted. This street is located off Peckham Road at the New Bedford-Acushnet town line. Half of this street is located in New Bedford.

## ANNUAL TOWN MEETING

April 26, 1976

**Article 2:** Unanimously voted that the Town Treasurer, with the approval of the Selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning July 1, 1976, in accordance with the provisions of General Laws, Chap. 44, Sec. 4, and to issue a note or notes therefore, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with General Laws, Chap. 44, Sec. 17.

**Article 3:** Unanimously voted to accept Article 3 as amended. To see if the cemetery board shall receive such compensation for their respective services. Such amounts not to exceed the receipts from grave openings, misc. fees from cemetery lots maintenance, and interest payable within the year on sundry perpetual care funds, and also money from Cemetery appropriation for works done on lots not in perpetual care.

**Article 4:** Unanimously voted to transfer from Federal Revenue Sharing Acct. the sum of \$6,864.50 for the purpose of two (2) new Police Cruiser Cars.

**Article 5:** Unanimously voted to utilize Federal Revenue Sharing funds received or to be received and that the sum of \$248,150.00 be applied to Article 1, 12a and 12b. (Police Salaries and Departmental Expenses.)

**Article 6:** Unanimously voted by 2/3 vote to table Article 6. To see if the Town will vote to appropriate an amount not to exceed ten (10) percent of the amount raised in 1975 by taxation of real estate and tangible personal property for the purpose of contributing a Stabilization Fund in accordance with the provisions of General Laws, Chapter 40, Sec. 5B.

**Article 7:** Unanimously voted to raise and appropriate thru taxation the sum of \$37.95 to compensate Mr. Richmond Morse, 88 Keene Road, Acushnet for damage caused to his automobile due to alleged poor condition of Middle Road, just north of Leonard Street.

**Article 8:** Unanimously voted to accept JOSEPH STREET 1,010 feet westerly from the west line of Earle Street, to the east side of Helen Street, as per plan on file in Town Clerk's office as per plan of Arthur C. Thompson, Inc., Engineers & Surveyors, Marion, Mass., dated November 12, 1975.

**Article 9:** Unanimously voted to accept NORMAN STREET, 520 feet easterly from the northeast side line of Sears Lane, as per plan on file in Town Clerk's office as per plan of Arthur C. Thompson Inc., Engineers & Surveyors, Marion, Mass. dated November 12, 1975.

**Article 10:** Unanimously voted to accept plan accepted by Planning Board, November 23, 1964, Village View Heights, recorded at Registry of Deeds, Book 68, Page 42, John Hopp and Alice A. Hopp, deed recorded December 30, 1942, Book 864, Page 314.

**Article 11:** Motion failed to pass to see if the Town will vote to raise and appropriate or transfer from available funds a sum of \$660.00 for the layout of CRANDON DRIVE.

**Article 12:** Motion failed to pass to accept MARTEL STREET as laid out under Article 11, 1974 Annual Town Meeting, as per plan of Tibbetts Engineering Corp., dated June 28, 1974.

**Article 13:** Unanimously voted to reconstruct DAYTON STREET, 35 feet wide per plan of Corse & Tibbetts, dated December 10, 1959, Crompton Street to Main Street, 360 feet, and transfer from the Nye Avenue Account the sum of \$2,425.36, and to take from article 30, the sum of \$6,079.64.

**Article 14:** Unanimously voted to reconstruct WAMSUTTA AVENUE from Pedro Street to Parkside Avenue and transfer from money raised on Article 30 the sum of \$1,820.36 and from Article 31, the sum of \$2,409.64.

**Article 15:** Motion failed to pass to reconstruct WARD STREET from Middle Road to present accepted terminus, 1,200 feet more or less.

**Article 16:** Unanimously voted to amend the Protective By-Law as follows:

Section 3.2 & Strike out Section 3.2 (a) and insert in place thereof: (a) where public water supply is used, on a lot containing not less than 15,625 square feet and having a lot frontage and width of not less than 125 feet.

Also strike out Section 3.2 (b) and insert in place thereof: (b) where public water supply is not used, on a lot containing not less than 30,000 square feet and having a lot frontage and width of not less than 150 feet.

Also regarding Section 3.6 — strike out the last sentence and insert in place thereof the following sentence: This section of the By-Law shall not apply to any building which has a front yard set back in excess of 75 feet. (2/3 vote taken — hands not counted).

**Article 17:** Unanimously voted to accept the provisions of Massachusetts General Laws, Chapter 147, Section 17B, which reads as follows:

“Notwithstanding the provisions of any general or special law to the contrary, the services of all regular or permanent police officers of every city and town which accepts this section shall be restricted to

five days and to forty hours in any one week; provided that the service in excess of the aforesaid days and hours may be authorized by the Police Commissioner, Chief, Superintendent or other officer or Board at the head of the Police Department of any such city or town and the officer performing such additional service shall be compensated at the hourly rate of his regular compensation for his average weekly hours of regular duty or such higher rate as may be determined by the person or persons authorized to establish pay scales in the respective police departments. The compensation payable to any such officer shall not be reduced by reason of the acceptance of this section. This section shall take effect in a city having a Plan E or Plan D charter when accepted by the affirmative vote of a majority of the city council and in the case of other cities by vote of the city council, subject to the provisions of its charter, and in a town by majority vote at the annual town meeting."

**Article 18:** Unanimously voted to appropriate the sum of \$300.00 thru taxation under the provisions of Chapter 41, Section 100E of the General Laws of the Commonwealth to effect insurance providing indemnity for the Board of Selectmen and any other Town officers designated by the Board of Selectmen for expenses or damages incurred by them in the defense or settlement of any claim against them which may arise while such officer or officers are acting in the scope of his official duties or employment.

**Article 19:** Unanimously voted to accept the provisions of Chapter 40, Section 21 (17), (19) of the General Laws, regarding:

(17) For prohibiting or regulating the removal of soil, loam, and sand or gravel from land not in public use in the whole or in specified districts of the town. The superior court shall have jurisdiction in equity to compel compliance with any ordinance or By-Law made hereunder. The penalty for violation of any ordinance or By-Law made hereunder shall be as follows: for the first offense, fifty dollars; for the second offense, one hundred dollars; and for each subsequent offense, two hundred dollars. Any order or By-Law prohibiting such removal hereunder shall not apply to any soil, loam, sand or gravel which is the subject of a permit or license issued under the authority of the town or by the appropriate licensing board of such town or by the Board of Appeal, or which is to be removed in compliance with the requirements of a subdivision plan approved by the town planning board. (19) For requiring any person excavating land or any person in charge of such excavation and for requiring any owner of land which has been excavated to erect barriers or take other suitable measures within two days after such person has been notified in writing by the mayor or city manager and the city council, the selectmen or the building inspector, of the city or town in which the land is located that in their opinion such excavation constitutes a hazard to public safety. The penalty for

violation of any ordinance or By-Law made hereunder shall not exceed two hundred dollars per day for every day such person is in violation of such notice commencing with the fourth day thereof. The superior court shall have jurisdiction in equity to compel compliance with any ordinance or By-Law made under the provisions of this clause. Notwithstanding the foregoing, no person shall be found guilty of a violation of such an ordinance or By-Law, nor shall a person be compelled in equity to comply therewith unless, in the opinion of the court, such excavation constitutes a hazard, or take any other action relative thereto.

**Article 20:** Unanimously voted to accept the provisions of Chapter 40, Section 21 (22) of the General Laws, regarding:

(22) For controlling and abating noise from whatever source, including, without limiting the generality of the foregoing, the right to restrict or limit the use of automobile horns and the operation of motor vehicles in such a manner as to cause excessive noise, or take any other action relative thereto:.

**Article 21:** Unanimously voted to amend Article III, Financial Affairs, Section 15, of the Town By-Laws relative to Town Counsel being authorized to institute any suit involving not more than \$300 which he may think the interests of the town require, without instructions from the town in lieu of \$300 authorization; substituted the figure of \$1500 as voted.

**Article 22:** Unanimously voted to amend Article IV, Section 12 of the Town By-Laws, by adding as follows: whoever is found to be guilty of said violation by appropriate Court be subject to bearing all costs expended in to this matter. Motion made to further amend Article IV, Section 12 of the Town By-Laws by adding as follows: "To except antique automobiles in this article." It was unanimously voted to adopt the amendment "to except antique automobiles."

**Article 23:** Unanimously voted to postpone indefinitely to pay an additional 25%, to the payment of 50% of a premium for Contributory Group Life and Health Insurance for employees in the service of the Town and their dependents, whereby full cost to the town would have been 75% of total premium.

**Article 24:** Unanimously voted to adopt Article 24 allowing John T. Koska to tie in his drainage system at the extension of Park Drive into the Northwest Master Drainage system, with the said John T. Koska to pay all of the costs of the same and to be responsible for the same.

**Article 25:** Unanimously voted to raise and appropriate through taxation the sum of \$843.42 as payment to Tibbetts Engineering Corp.,

New Bedford, for unpaid engineering-professional services rendered in May and June 1975 relative to reconstruction and curbing at Lisa Avenue.

**Article 26:** Unanimously voted to postpone until next annual Town Meeting to decrease from five School Committee members the three School Committee members to persons who may vote to fill vacancies or make appointments to the Old Colony Regional Vocational School Committee, so as to create an even vote, so that there will be three School Committeemen, three Selectmen, and the Town Moderator, who may vote to fill vacancies or make appointments to the Old Colony Regional Vocational School to vote this same article so as to comply with the Old Colony Regional Vocational School Agreement.

**Article 27:** Unanimously voted to raise by Transfer from E & D Account the sum of \$1.00 as per amendment #1 to purchase the following equipment and materials in accordance with "Applications for Funding Assistance" filed with the Commonwealth of Massachusetts, under the Governor's Highway Safety Bureau requesting complete reimbursement for the purchase of the following:

(a) Police Traffic services: One (1) New Van Truck and all equipment as listed the application.

(b) Pedestrian Safety: All equipment necessary to set up a complete highway safety program, including projectors, screens film, etc. as listed in the application.

(c) Street Equipment: Pavement striper and Traffic counter as listed in the application.

Amendment No. 2 to this article was unanimously voted on by Town's people — instructing the Board of Selectmen that at no time they be allowed to add personnel to operate this equipment.

**Article 28:** Unanimously voted to raise or appropriate the sum of \$10,000.00, to be used only in conjunction with future Federal, or State or Local Aid only if it is forthcoming for the specific purposes of purchasing a new modular Class Ambulance, and equip said vehicle with necessary equipment according to Mass. General Laws, C.111C.

**Article 29:** Unanimously voted to transfer from E & D Account the sum of \$8,687.91 for payment of retroactive salaries to the Police Department. Said funds as result of Binding arbitration award made in 1975.

**Article 30:** Unanimously voted to raise by taxation the sum of \$7,900.00, for Town funds to be used in conjunction with and in addition to any funds allotted by the Commonwealth and/or County for the construction, reconstruction and improvements of town roads.

**Article 31:** Unanimously voted to raise from taxation the sum of \$12,000.00, for improvements of town roads as requested by the Board of Selectmen.

**Article 32:** Unanimously voted to raise by taxation the sum of \$1,200.00 to engage the services of a public stenotypist for all town meetings, and provide a sum of money therefore.

**Article 33:** Unanimously voted to transfer from the Stabilization Fund the sum of \$27,750.00 for the purpose of repairs and maintenance work at the Town Hall, including compensating architect.

**Article 34:** Unanimously voted to transfer from the STABILIZATION FUND the sum of \$25,000.00 as preliminary moneys for reassessing the properties at a full and uniform assessed valuation. (100% valuation.)

**Article 35:** Unanimously voted to transfer the sum of \$2,800.00 from a sale of Real Estate Fund and raise through taxation the sum of \$2,200.00 to conduct a summer recreation program cooperatively run by the School Department and the Park Department.

**Article 36:** Voted unanimously to postpone indefinitely the purchase/lease of a business machine.

### **SPECIAL TOWN MEETING June 14, 1976**

Moderator called the meeting to order (by Moderator A. P. Stuart Gilmore) at 7:00 P.M. Monday, June 14, 1976. Quorum was not present, therefore, we waited until 7:30 P.M. At 7:30 P.M. a quorum (147) of voters still wasn't present. At this time the Selectmen made a motion that we adjourn until the following Monday, June 21, 1976, motion seconded and adjourned until then.

June 21, 1976, meeting called to order at 7:00 P.M. Quorum absent, and we unanimously voted to adjourn the meeting, at 7:05 P.M. In the meantime the Town Accountant, Wilfred C. Fortin, contacted Division of Accounts in Boston, and the amount needed to cover Articles 1, 2 and 3 in the amount of \$11,443.37 was approved to run in Deficit Spending, into Fiscal 1977.

**Article 1.** To see if the Town will vote to transfer a sum of money from available funds to the Police Department salaries account, or take any other action relative thereto. (\$7,660.75)

**Article 2.** To see if the Town will vote to transfer a sum of money from available funds to the Police Department departmental expenses account, or take any other action relative thereto. (\$2,101.30)

**Article 3.** To see if the Town will vote to transfer a sum of money from available funds to the Street light account, or take any other action relative thereto. (\$1,681.32)

### **SPECIAL TOWN MEETING October 25, 1976**

**Article 1.** Unanimously voted that the Board of Selectmen act as Sewer Commissioners and pursuant to General Laws Chapter 41, Section 21, have the Selectmen place the question on the official ballot at the next Annual Town Meeting.

**Article 2:** Unanimously voted to transfer from the Overlay Reserve the sum of \$11,000.00 for the purchase of a new Class 1 Ambulance as required by State Law, Chap. 111C and equip said vehicle with necessary equipment to comply with the law. This additional sum to be used in conjunction with sum of \$10,000.00 appropriated at 4/26/76 Annual Town Meeting, of which a total of \$12,000.00 is to be reimbursed to the Town by the Governor's Highway Safety Program.

**Article 3:** Unanimously voted to authorize its Selectmen to submit an application for the construction of a water system under the Public Works Employment Act of 1976 (P.L. 94-369) and expend any monies received in accordance with said application.

**Article 4:** Unanimously voted to authorize the Board of Selectmen to transfer the sum of \$2,000.00 from Water Revenue to retain an engineer to prepare and file any necessary applications or documents with any Federal or State agency to obtain planning and construction of a water system.

**Article 5:** Motion failed to pass to amend Section 3.2 (a) (b) of the Town Protective By-Law, regarding minimum lot size. The amendment would have been as follows: "No dwelling shall hereafter be erected on any new lot containing less than 40,000 square feet and having a frontage of less than 150 feet, (Planning Board held necessary hearing 9/28/76.)

**Article 6:** Unanimously voted to transfer from Federal Revenue Sharing the sum of \$4,000.00 authorizing the Board of Selectmen to retain an engineer to prepare engineering plans toward the construction of a sewage system, Step 1.

**Article 7:** Unanimously voted to adopt the following By-Law: No alcoholic beverages shall be consumed by anyone on Town property such as parks, school grounds, including Town Buildings, except by license or permission from those in authority.
