thoughts of the view of town meeting, it is an institution in essence it has been a
bedrock and given citizens their chance to discuss their thoughts it is worth
discussing get town meeting thoughts of it, absolutely meet with finance
committee. Chairman Desroches said absolutely meet with finance and he also
has thoughts with Selectman Wojnar and also Selectman Gaspar is on Board.
Selectman Wojnar motioned to entertain joint meeting, Selectman Gaspar
seconded and all were in favor. Motion Passes.

The police have been great and it is a start doing increments at a time created a petition for the board to see the residents want the speed limits changed and with the changes Eversource has done to the street, trailers and cars are bouncing over the road.

# 2. <u>DINA BRASSUER- LIBRARY DIRECTOR & HEATHER SYLVIA, COA DIRECTOR OPEN UP DISCUSSION THE COA HAS BEEN OPEN SUCCESSFULLY SINCE 6/1 LUCKILY AND NO POSITIVE TESTS SINCE.</u>

We are asking for a mask mandate while people are in the building we service a lot of people we would like to revisit it and take your opinion first and for most. Dina Brassier very similar if there was a mandate there are a lot of people who do wear masks people would feel more comfortable if mask were worn Library Trustees think it might maybe more layer of protection for not only the staff and other people that are in the building. Month by Month put things on social media and website make majority feel better.

Selectman Gaspar not a mandate kind of person understand things going on however; we are in a very unusual time right know. To Ms. Sylvia-I appreciate your effort in the past people coming into the building doing vaccinations and testing do spend a lot of time in the building.

Selectman Wojnar maybe call it policy less transactional —be hard pressed to say no make policy masks are required is a safety & welfare of the people and no problem to wear masks in the library and council on aging, Selectman Gaspar voted to have the Library & COA masked areas. Hopefully we can stop the spread. Let's keep everyone safe.

#### 3. WAGE & CLASS STUDY

This discussion is pretty much the library clerks and dispatch we were presented with plan and tabled 6 weeks ago.

Selectman Gaspar doesn't like going into specifics and would like this going into executive session thinks it would be better. Selectman Wojnar not ready to move on this and need a few more details how contracts to be negotiated with police and other unions.

Selectman Gaspar motioned to pay Mr. Jacobs and not vote to accept or implement study at this time, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### V. NEW BUSINESS

#### 1. FALL TOWN MEETING DATE

Selectman Gaspar likes the idea of Fall town meeting type up loose ends housekeeping issues or even some ideas on solar pilots discussing things and hopefully don't end up without a quorum.

Solar pilots and pilot agreements might be the way to go we could maybe pay for the

roof at the school.

Chairman Desroches legitimize zoning issues and potential finance issues, and CPC issues if there are things we can do that we have to wait till town meeting change the course and have on the books with no budget issues and is fine with January 10<sup>th</sup> Selectman Gaspar motioned to hold town meeting on January 10, 2022, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### 2. SCHEMATICS MSBA

Town Administrator, Ms. Hebert explained if not approved would have to go out for new OPM and contractor the contract for designer services went up \$82,000. It seems confusing for a difference of \$8200 because working with MSBA will pick up the 50 % of the increase most likely they will share. Also looked at comparable towns felt like it was the best interest for the town since the cost of lumber is going up. Selectman Gaspar motioned to approve, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### 3. CARES FUNDING

\$2700 air filters –Selectman Gaspar motioned to approve the funding of the air filters, Selectman Wojnar seconded and all were in favor. Motion Passes.

The Finance Department is looking to keep things going smoothly with the CARES funding and would like to use the temp. person for help with the checklist and forms that accompany the funding. Looking for about \$3,000 for the temporary help. Selectman Gaspar motioned to approve the funding, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### CIVIC PLUS

Covered by cares more basic looking technology improvement, will make improvements to website. Selectman Gaspar motioned to approve the funding, Selectman Wojnar seconded and all were in favor. Motion Passes.

Check with Cathy Muller –Treasurer/Collector about bill pay services a business owner, and or residents use credit cards let everyone know we need to explore that we are not exceeding the percentage rates and get updates for next meeting or October 1<sup>st</sup>.. The Police Chief is looking for portable equipment software & print machine, right now if they have someone in the cell block have to cancel gun license appointments. The Chief has spoken to other departments and they are using the same systems. Amount requested is \$9,043.13. Selectman Gaspar motioned to approve the funding, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### 4. RIGHT OF FIRST REFUSAL PARCEL ID 17-24 A, B & C

Borrego is asking to waive the right of first refusal on the above parcel. The Town's frustration is not with you but with Eversource regarding interconnectivity.

Morse's Lane project has gone through with planning, went to conversation and

stormwater conservation and planner to make sure this project has been approved. To convert the property and requesting a waiver will have to work with assessor's office.

Assessors have no objection to this and if the BOS would like an appraisal –value of land present and full cash value.

Selectman Wojnar spoke about solar pilots doesn't want to keep assessment over what project assessed at.

90% pilot in a steady stream depreciates very quickly tax obligation is always there. Tax revenue goes into capital expenditure fund. Pilots make plenty of money and upside makes great sense.

It would be prudent for the Town going forward moving to pilots.

It's always better to negotiate Borrego—has done 50 pilots in Massachusetts and would be willing to come in and give information about the pilot program there are all sort of exemptions and use money for what we want.

Selectman Gaspar motioned to forgo our right of first refusal for Parcel ID 17-24 Morse's Lane, Selectman Wojnar seconded and all were in favor. Motion Passes.

## 5. RESERVE FUND TRANSFERS (Planning Department)

The Town Planner needs office supplies for his new clerk. The last clerk mostly worked from home and they did not have an office supply line item. Selectman Gaspar motioned to approve up to \$2,000 as a starter kit, Selectman Wojnar seconded and all were in favor. Motion Passes. Discussion was also made to update Planner with GIS software need to get more info on the matter.

The special project manager & temp town planner should have been paid through June 30<sup>th</sup> the amount is \$1104.55. Selectman Gaspar motioned to approve, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### VI. DEPARTMENT OF PUBLIC WORKS

### 1. CITY OF NEW BEDFORD WATER/SEWER RATES

Kathy Silva came in from the DPW to explain the water/sewer rates that the city of New Bedford have raised by 7.17% increase in water rates. I like to come now once the budget is done and close out the year it gives a better analysis; water usually do 5 year average this time I did FY22 budget. \$100,000 buffer for the New Bedford line item-Kathy feels comfortable with the .15 cent increase and reevaluate next year.

NB sent notice all rate increases by March would have inclination what we would pay and now they gave us the rates from held a meeting on July 13, 2021 and went up .30 the Town should have been notified sooner of the increases.

Kathy reached out reached out to Mr. Lafonde from the City (has a good working relationship with DPW). Ms. Silva checked different scenarios and feels the rate should

go up based on numbers, we should go up in our reserve by \$165,000.00. Selectman Gaspar approves the rates per tier, Selectman Wojnar seconded and all were in favor. Motion Passes. Please see attached water/sewer rate fees.

Ms. Silva stated last year received \$117,000 don't know what we had at that point but feels comfortable.

Sewer pump stations why increase rates we usually know what we make

What was our surplus in May, we could be talking in our surplus account, could be over \$400,000 Selectman Gaspar motioned to not increase sewer rates for FY22, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### 2. <u>SEWER PRIVELGE FEE</u>

Selectman Gaspar motioned to approve 55 Club Avenue sewer privilege fee the parcel detailed has applied to the connection into the sewer system, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### 3. SENIOR TAX DEFERAL -

This deferral allows the homeowner under income guidelines to defer taxes and upon the house sale they pay the deferred tax to the Town. Selectman Gaspar motioned to approve the Senior Tax Deferral, Selectman Wojnar seconded and all were in favor. Motion Passes.

#### VII. TOWN ADMINISTRATORS REPORT

The Police Chief asked to mention\_the partnership from the Children's Advocacy of the month for the Multi-Disciplinary Team Jeremy Fonts & Ryan Hemphill for bringing spirit, humor and Commitment to MTD., job well done. No Vote Taken.

Discussion of current policy for DPW with Eversource and road openings. No Vote Taken.
