III. MEETING MAIL

1. LETTER OF RESIGNATION FROM BY-LAW REVIEW COMMITTEE

Ray Leblanc resigned from the By-law Committee after serving the town for over 30+ years. The Board of Selectmen thanked Mr. Leblanc for his years of service to the Town. No vote taken.

2. LETTER OF RESIGNATION FROM TOWN MODERATOR

Roger Cabral resigned from the Town Moderator position due to moving out of Town. Selectman Desroches said that there will be an opening for Town Moderator and they will leave the position open for a month and decide on a appointment at the next meeting. Anyone interested in the position should send a letter of interest to the Selectmen's Office. Mr. Desroches said whoever is chosen as Town Moderator will hold the position until the next election in May, 2022, when the person can run for reelection. The Board of Selectmen thanked Mr. Cabral for his years of service to the Town. No vote taken.

LETTER OF RETIREMENT FROM OFFICER JAMES COSTA

Officer Costa retired from the Police Department after working for the town for 33 Years, the Board recognized his years of service and gave him a great thanks. The Board also voted to make Officer Costa a Special Police Officer for the Town to assist in Traffic Details. 2. GOLF PERSONNEL EMPLOYMENT AGREEMENTS-

The Board discussed wage & class for Golf Employees Selectman Gaspar mentioned that he did some work on numbers and is fine with the grade, but wasn't fine with the numbers. Would like to have a conversation with golf Committee maybe do something different and make a plan to work with golf

Committee to make up a compensation for over 40,000 rounds. This is not from taxation may be more profitable that way. Selectman Gaspar motioned to accept the Personnel Agreements as presented, Selectman Wojnar seconded and all were in favor. Motion Passes.

3. FIRE CHIEF ASSESSMENT CENTER RFP

Chief Gallagher put together an RFP for Consulting Services to Design and Conduct Assessment Centers for the Selection of a Fire Captain in his retirement in the future. Selectman Gaspar motioned to approve and send out the RFP, Selectman Wojnar seconded and all were in favor. Motion Passes.

1. ROUND TWO: END OF YEAR INTER-DEPARTMENT TRANSFERS

Melissa Forgue –Town Accountant described inter-department transfers for FY21. Chief Gallagher & Chief Richmond also gave input as to their budgets. 2. CONSERVATION /STORMWATER AGENT APPOINTMENT

The Board discussed the contract for the Conservation /Stormwater Agent position. The Agent shall be paid an hourly rate of (Grade 11, Step 4) \$30.47 to commence July 12, 2021 through June 30, 2022, payable in bi-weekly installments for working 20 hours per week. It is understood that the Agent is also working on a part-time basis for the Board of Health in the role of Part-time Assistant Health Agent and the Board retains the right to reduce or eliminate his hours in that capacity. Selectman Gaspar motioned to appoint, Selectman Wojnar seconded and all were in favor. Motion Passes.

CHAPTER 90 DOCUMENTATION AUTHORIZATION (ASPHALT ROLLER)
