MEETING MAIL

LETTER FROM LES DAKIN REQUESTING THE AIRING OF A DOCUMENTARY REGARDING THE TRANSMISSION OF LNG DVD ON CHANNEL 18-Former Selectmen Les Dakin is petitioning the Selectmen to air a documentary regarding the transmission of LNG as a public service announcement on channel 18 our local government channel.

Selectman Gaspar motioned to approve airing the LNG documentary on Channel 18 for 30 days, Selectman Desroches seconded and all were in favor.

RESIGNATION LETTER FROM AN AGRICULTURAL MEMBER- The Board received a letter from Mr. Richard Miranda resigning from his appointment on the Agricultural Commission. The Board wishes to thank Mr. Miranda for taking the time to be involved in the Ag Comm. affairs and attending the meetings. No vote to be taken.

RESIGNATION LETTER FROM AN ELECTION INSPECTOR-The Board received a letter from Ms. Joanne Cioper resigning from her appointment as an Election Inspector. The Board wishes to thank Ms. Cioper for taking the time to be involved in Town Elections. No vote to be taken.

APPOINTMENTS

Joint Meeting between the Town Moderator, Board of Selectmen and the Acushnet School Committee regarding the appointment of the Old Colony School District Representative (Evelyn Bouley). Present for the School Jennifer Downing, Craig Sumner, Sarah Gomes-motioned to open the school committee meeting Mr. Sumner 2nd. They all feel Ms. Bouley does a great job with being the liaison for Acushnet with Old Colony. All Selectmen are in agreement with the School committee about Ms. Bouley's commitment. A roll call vote was taken Selectman Gaspar-yes, Selectman Desroches-yes and Chairman Cabral is a yes. Motion passed. Roll Call vote was taken Sarah Gomes- yes, Mr. Sumner –yes and Jennifer Downing-yes all in favor. Ms. Gomes made a motion to close the school committee joint meeting with the Board of Selectmen, Ms. Downing 2nd and all were in favor.

Jim Marot-Building Commissioner to discuss the Green Community and give updates of what we have been doing to the Town Buildings. The Town has been receiving in excess of \$100,000 every year. Massachusetts is the greenest State in the Country. If the Town signs with ECA Solar for net metering credits, could save the Town over \$51,000 in energy per year for 20 years. If the Net Metering Credits 20 year plan passes at Town Meeting, we are not obligated to choose ECA. Cotuit Solar sold to Duxbury, Kearsage Energy is interested in selling too. Why not grab

the credits while we can. Eversource is giving the Town at no cost 10 charging stations for electric cars. The Town also purchased the street lights and that should be a saving of roughly \$30,000 per year. Great Job Jim keep up the good work. Mr. Marot also spoke about the Property Maintenance Article for abandoned properties and applying for a grant for software through the Community Compact for e-permitting. No votes taken.

OLD BUSINESS

ACUSHNET FIREFIGHTERS LOCAL 3281 MEMORANDUM OF AGREEMENT APPROVAL-The Fire Fighters Local 3281 have agreed to a 3 year contract with a 2% COLA for years 2 & 3, this will merge the Fire Fighter & EMS Departments. This agreement will remove the staff from civil service with approval from Town Meeting and the Legislature. Tabled at this time until the Board receives the last signature.

To Approve Article 17 on the Town Meeting Warrant (Removal of the Fire Fighters/EMS Uniformed Positions out of Civil Service)- This article was approved by the Fire/EMS Department as a stipulation of the Memorandum of Agreement to merge the two departments. We have a verbal agreement with the Union and are just awaiting one more signature. Selectman Gaspar motioned to approve Article 17 on the Town Meeting Warrant as presented, Selectman Desroches seconded and all were in favor.

TOWN MEETING WARRANT REVIEW- The Board voted at their last meeting the approve Articles. At this meeting The Board voted to approve Article 17 being the last Article to approve. Selectman Gaspar motioned to approve the Annual Town Meeting Warrant as amended in its entirety, Selectman Desroches seconded and all were in favor.

NEW BUSINESS

Approval for the Collection & Transportation of Rubbish & Recyclables Agreement- The Town has been in agreement with Howland Disposal for Rubbish & Trash pick-up since 2016 with an ending date of 2021. Waste Management has entered into an Asset Purchase Agreement with Howland Disposal. The Town hereby confirms to all the terms and conditions of the Consent to Assignment. Selectman Gaspar motioned to approve the Consent to Assignment with Waste Management as presented, Selectman Desroches seconded and all were in favor. Dan Menard was in attendance and Selectman Gaspar asked some questions regarding the payment breakdown in the contract, Mr. Menard also spoke about the recycling of plastic bags being the largest contaminant. Kathy Silva is going to a seminar on how to get a grant for better recycling.

One Day Special Liquor License Approval for Gifts to Give, June 1, 2019 from 5 pm-9 pm-Jim Stevens from Gifts to Give has requested a One Day Special Liquor License on June 1, 2019 from 5 p.m.-9 p.m. for an annual clambake fundraiser at the Gifts to Give Headquarters located at 1 Titleist Drive, Acushnet. The Fire Chief, Police Chief and Bldg. Inspector have signed off on the request and the Liability certificate is in order.

Selectman Gaspar motioned to approve the Special One Day Liquor License for Gifts to Give on June 1, 2019 from 5 p.m.-9 p.m. as presented, Selectman Desroches seconded and all were in favor.

Golf Rate Increase Approval- The Golf Committee voted to recommend the following rate increases for the 2019 season. The proposed rate increases are small and should not impact rounds of play. Based on rounds played last season, this should increase revenue by \$11,300. There will be a one dollar increase to weekend 18 hole walking (\$47-\$48), Weekend Twilight (\$39-\$40), Weekday 18-hole Special (\$49-\$50), Weekday Twilight (\$39-\$40) Selectman Gaspar motioned to approve the rate increase for the 2019 golf season as presented, Selectman Desroches seconded and all were in favor.

Annual Appointments Approvals (see attached list)-The Town Charter Section 4:3-4-1; the power to appoint shall be vested in the Board of Selectmen and the term of office may also be fixed by the Board of Selectmen. The list of Committee & Board Members up for reappointment in the year 2019 are before us and posted with the Meeting Agenda. Selectman Gaspar motioned to approve the annual re-appointments as read, Selectman Desroches seconded and all were in favor.

TOWN ADMINISTRATORS REPORT

Nick Gomes, Moderator spoke about sorry he was late and setting up a date for the Town Meeting Forum.

Town Meeting Forum is scheduled for Monday, April 29, 2019 time to be determined. Town Meeting is scheduled for Monday, May 13, 2019 at 7:00 p.m.

The Police Chief has given his notice of retirement, we have checked into the situation and checked with Counsel, the RFP is with Counsel now for vetting and the board would also like to bring in Darren Klein to conduct strategy and the assessment center for the testing. We need to have a conversation with the current chief to figure out what his plan is and whether or not he would be interested in being an Interim Chief. The next scheduled Selectmen's Meeting will be May 7, 2019.
