Firearms License Application Checklist

- [] **Application:** Your application must be completed prior to your scheduled appointment. Please be sure to answer truthfully and type or print clearly. **NOTICE:** Question (10) of Page two (2) of the firearms application applies to all criminal charges ever brought against you, in the court of law, regardless of the final outcome. This means that if a case is found to be filed, dismissed, not guilty, pardoned, sealed, etc It is mandatory that it be noted with in the application. Be advised that if your application is not completed truthfully your *LTC* or *FID* request will automatically be **DENIED**.
- [] **License Fee:** A \$100 non-refundable fee is collected when applying for a license to Carry or Firearms Identification Card. A one (1) time \$25 non-refundable fee is collected when applying for a Restricted Firearms Identification Card. Personal checks, bank checks, or money orders are the only forms of payment accepted. Cash is not accepted. **NOTE:** The license fee is reduced to \$25 if you are a Federal, State, or Local Law Enforcement Agent. All fees are waived for applicants who are 70 years of age or older.
- [] **Identification:** You must bring either a valid Massachusetts Drivers License or a Massachusetts Identification Card.
- [] **LTC or FID:** If you are renewing your license to carry or Firearms Identification Card please bring with you your current/expired *LTC* or *FID*.
- [] **Citizenship:** You must bring with you proof of United States Citizenship. This only includes one (1) of the following items: Birth Certificate, Passport, or Naturalization Certificate. **NOTE:** Naturalized Citizens must bring in their naturalization forms which should include naturalization date, number, and place (city/state) of naturalization.
- [] **Proof of Residency:** Applicants must bring with them one (1) of the following items to prove their Acushnet Residency and or business: Utility invoice, Credit Card Invoice, Certified Voter

Registration, or Certified Business Registration. **NOTE:** The forms listed above are the only forms that will be accepted. Insurance invoices and documents from the Registry of Motor Vehicles **WILL NOT** qualify for submission.

- [] ***Safety Course Certificate:*** First time applicants must possess and bring with them a Massachusetts Hunter Safety or a Massachusetts State Police Basic Firearms Safety Certificate. **NOTE:** This does not apply to Restricted Firearms Identification Card applicants.
- [] ***Letter to Police Chief:*** If you are applying for a license to carry for any other reason than “hunting and target,” you must submit a letter addressed to Acushnet Police Chief Michael G. Alves specifying the reasons why requesting such a license.
- [] ***Appointment:*** All applicants are processed and submitted for review by appointment only. To make your appointment, call 508-998-0240. Please leave a message for Detective John Bolarinho and he will return your call.
