**Open Meeting:** Mr. Cenerizio made a motion to open the meeting at 6:30pm, Mr. Rawcliffe 2<sup>nd</sup> the motion, all were in favor, motion passes.

**Mr. Medeiros made roll call, present was himself, Mr. Cenerizio, Mr. Rawcliffe, Ms. Hamer and absent was Ms. Kelly and Mr. Menard.**

**Approve Minutes:** Mr. Rawcliffe made a motion to approve the minutes from April 27, 2016. Mr. Cenerizio 2<sup>nd</sup> the motion, all were in favor, motion passes.

**Discussion:** Mr. Medeiros opened discussion about PJ Keating operating in Acushnet on So. Main Street. Mr. Cenerizio made a motion to increase the fee for 2018 by \$500.00 which will now make their annual fee of \$5,500. Mr. Rawcliffe 2<sup>nd</sup> the motion, all were in favor, motion passes. Mr. Medeiros informed the board that Donald & Charlotte Coutinho on Middle Road, whom holds the other license in town to remove soil, they have a license but do not really remove soil. Mr. Medeiros recommended that a motion be made to not raise their annual fee and to leave at \$150.00. Mr. Cenerizio made a motion to keep Coutinho's fee at \$150. Mr. Rawcliffe 2<sup>nd</sup> the motion, all were in favor, motion passes.

**Mr. Medeiros discussed the bond for PJ Keating which is at \$768,000 and what it would be used for. Mr. Medeiros informed the board that in the past the soil board voted to allow for PJ Keating to only go down 500' and in the future when the quarry closes, the open hole would be used as a water reservoir for the surrounding communities so that it will not have to be filled in. Mr. Rawcliffe made a motion to keep the existing bond of \$768,000 as is. Mr. Cenerizio 2<sup>nd</sup> the motion, all were in favor, motion passes.**

**Approve Permits:** Mr. Rawcliffe made a motion to approve PJ Keating and Donald & Charlotte Coutinho's permits. Mr. Cenerizio 2<sup>nd</sup> the motion, all were in favor, motion passes.




