Mr. Cenerizio announced that he is commencing the Open session to go into Executive Session and will return after to vote in Open session on what was discussed and decided on in Executive Session.


Mr. Cenerizio reopened the Open session at 6:10. A motion was made by Mr. Lopes to reopen and seconded by Mr. Cenerizio.
