**New Business** 

- 1. Mr. Brown reminded all taxpayers that FY 2023 Actual Real Estate and Personal Property bills have been mailed. The deadline to file for an abatement is February 1<sup>st</sup>, 2023.
- 2. Mr. Brown reviewed that all Forms of List applications were mailed out to all active and potential new personal property accounts for FY 2024. The deadline to submit these applications is March 1<sup>st</sup>, 2023.
- 3. Mr. Brown also reminded taxpayers that Income & Expense forms were mailed out. The deadline to submit these applications is March 1<sup>st</sup>, 2023.
- 4. Mr. Brown reminded all taxpayers that FORM ABC's were mailed out for FY 2024. The deadline to submit these forms is March 1st, 2023.

- 5. Kelly explained that there was an error that occurred where PA was calculated on mixed use properties. The properties that were affected will receive letters with an abatement certificate that states the CPA surcharge credit.
- 6. Kelly discussed the FY 2024 budget. She gave 4 scenario 110 the Finance Committee and is waiting on feedback before reviewing further.
- 7. Kelly explained that Assessors received the request for the 2022 Town Report. She will draft a report for the next meeting.
