### Agenda Topics: New Business

1. The Certification of the Tax Rates for FY19 was approved on November 6, 2018. The Residential tax rate is \$14.18/\$1000 of value and the Commercial tax rate is \$18.20/\$1000 of value. A 25% tax shift was ratified by the Board of Selectmen for this Fiscal year.
2. The Commitment process for FY 19 Actual Real Estate and Personal Property taxes has started. It is anticipated that the commitment process will be executed timely by Kelly and handed over to the Collector for finalization and bills to be generated.
3. The 3<sup>rd</sup> and 4<sup>th</sup> quarter bills will be mailed on December 31, 2018. The Abatement period is January 1<sup>st</sup> through February 1<sup>st</sup>, 2019.
4. The Bristol County Assessors Association Annual Meeting is scheduled for December 7, 2018. Sue and Kelly are planning on attending.

The Board also voted to accept all of the Chapter applications that were reviewed and signed. A motion was made by Mr. Soares and seconded by Mr. Lopes.


The meeting was closed at 6:22 with a motion made by Mr. Lopes and seconded by Mr. Soares.


