APPROVE SEPTIC DESIGN PLANS/SUBDIVISION PLAN REVIEW:

Retreat Lot D – Peckham Road – Jorge DaSilva- Zenith Consulting Engineer:

New Construction: Jamie Bissonette from Zenith Consulting Eng. was present with Jorge DaSilva, owner of property and Joshua Arruda, seller of property, to present and discuss the septic design plan for approval. Some discussion ensued about the wall design as part of the septic system being proposed. Jamie asked if the board can approve the plan pending a stamped designed from a structural engine. Jamie informed the board he is not the person that is going to submit a structural design. Mr. Davignon made a motion to approve the plan and hold the permit until an acceptable plan submitted by a structural engineered wall detail is supplied to be attached to the plan; Mr. Fortin seconded the motion; all were in favor motion passes.

105 Porter Street - Brian Mello - Charon Associates, Inc:

Septic Repair with 1 added variance: Mr. Charon is present to explain the reasoning for submittal of a previously approved septic plan from three years ago. New changes to septic design due to new owner of property changing the house style and requesting new variance of 8' from the tank to the cellar wall. Mr. Davignon made a motion to approve new variance & approve the plan as read; Mr. Fortin seconded the motion; all were in favor motion passes.

52 Pershing Avenue – Carlos & Maria Nogueira – Alan Ewing Engineering, Inc: Septic Repair with no variances: Mr. Davignon made a motion to approve the plan as read; Mr. Fortin seconded the motion; all were in favor motion passes.

11 Mattapoisett Road – Edward & Nancy Sylvia – Alan Ewing Engineering, Inc: Septic Repair with 1 variance for a reduction to Groundwater from 4' to 3': Agent Correia explained this is a voluntary repair by the homeowner and would like the in-ground pool removed and place leaching field in its location. Agent Correia will be on location while excavation done on site to witness soils under the pool. Mr. Fortin made a motion to accept the variance and accept the plan as read; Mr. Davignon seconded the motion; all were in favor motion passes.
