Tobacco violation at 1 Middle Road, Town Liquors. Owner Appealed the Violation and has requested a hearing. The owners did not appear at the meeting, Megan DaCosta, our compliance officer, was present and explained they had a 16-year-old go into the liquor store and purchase "Backwoods" mini cigar without being asked for an ID. Discussion ensued about past practice for violators selling to minors. Chairman Fortin would like to waive the 1<sup>st</sup> violation because this is the first time and that they are new owners, however if they violate the regulation again they will pay the full fine. Mr. Medeiros did not agree and suggested that the board charge the full fine and feels that would make a statement and put the clerk on alert to be more cautious with checking ID's. Mr. Davignon commented that the fine of \$1,000 is too high. He doesn't want to forgive a violation but would recommend reducing the fine to a smaller amount and agrees that if they have a 2<sup>nd</sup> violation that they pay the \$2000 fine. Discussion ensued about the owners not being present to defend themselves. Mr. Davignon states that his opinion in the matter wouldn't change regardless if the owners were present or not. Mr. Medeiros made a motion to fine the establishment for violating the sale to a minor for the required amount of \$1,000, Mr. Davignon seconded the motion, roll call vote Mr. Medeiros "yes" Mr. Davignon "no" Chairman Fortin "no" motion does not pass 1 – 2 vote.

Mr. Davignon made a motion to charge a reduced fine of \$100 in lieu of \$1,000 followed up with a letter to make it clear that the second violation will not be reduced, Chairman Fortin seconded the motion, roll call vote, Mr. Davignon "yes" Chairman Fortin "yes" Mr. Medeiros "no". Motion passes 2-1 vote.
