Minutes for approval: R. Rezendes made a motion to approve the April 27, 2022 minutes. H. Pelletier seconded the motion. Motion passed 4 -0.

Old Business:

Continued (Public Hearing) NOI – Acushnet Company / 115 Manchester Lane SE 001-0571 A Notice of Intent was filed by Acushnet Company for property located at 115 Manchester Lane, Map 11, Lot 25C.34. The applicant proposes to construct a 55' X 110' visitors center with associated parking lot reconfiguration, utilities, subsurface sewage disposal system and stormwater management system within the 100' buffer zone to a bordering vegetated wetland. Work proposed is limited to drainage improvements and construction of an infiltration basin. The applicant is represented by William Madden of G.A.F. Engineering. Plan name is "Test"

Facility Visitors Center prepared for Acushnet Company" dated April 26, 2022. Stormwater report not finalized. R. Rezendes made a motion to continue to July 27, 2022. H. Pelletier seconded the motion. Motion passed 4-0.

Continued - Restoration Plan - Jason Carvalho / Lot 9B Keene Road SE 001-0572 Restoration plan review for property located at Keene Road, Map 3, Lot 9B. Motion passed 4-0.

Continued (Public Hearing) NOI – Jason Monteiro / 48 Cushman Street SE 001-0573 A Notice of Intent was filed by Jason Monteiro for property located at 48 Cushman Street, Map 15, Lot 586. The applicant proposes to raze the existing dwelling and build a new single family dwelling with associated utilities and site grading. The applicant is represented by Nyles Zager of Zenith Consulting Engineers, LLC. Plan name is "Plan to Accompany Notice of Intent - 48 Cushman Street, Acushnet, MA" dated May 23, 2022.
