VI. New Business:

NOI – Vieira Realty Trust / Andy's Court (SE001-0524) – A Notice of Intent was filed by Vieira Realty Trust for property located at Andy's Court, Map 9, Lot 31G. The applicant proposes to construct a 3-bedroom single family dwelling which will be partially located within the 100 ft. buffer zone of the bordering vegetated wetland, and install a 12X12 utility shed in the rear yard. The applicant is represented by N. Douglas Schneider & Associated, Inc. Plan name is "Sewage Disposal System – Site Plan for property located at Andy's Court in Acushnet, MA". Plan dated 11/16/17.

Robert Rocha stated the wetlands flags are still in the process of being replaced to identify the wetlands line. He also mentioned the wetlands line had been approved in a previous ANRAD and it was also approved by the Commission. He also said the Commission had spoken with the property owner and agreed to continue till the next meet December 26, 2007 in order to give them time for the flags to be replaced.

A motion was made by Heidi Pelletier to table the filing until the next meeting, December 26, 2017. The motion was seconded by Everett Philla. Motion passes 4-0.

COC – Dubois/ 100 Perry Hill Road (SE001-00518) – A Certificate of Compliance was filed by Russell Dubois for property located at 100 Perry Hill Road Map 9, Lot 18. The applicant proposed to construct a 28' by 30' garage as an accessory structure to the existing single family dwelling. Plan name "As Built", plan dated 11/13/17.

Agent Kelly said the grass was all in and looked good. She explained the project had been completed on the outside. Everett Philla did state he had hoped the apron in front of the garage would have been on. Mr. Philla said where the apron would be poured in front of the garage would not be a problem. He also stated he had no problem approving the COC though.

A motion was made by Everett Philla to approve the COC for 100 Perry Hill Road. The motion was seconded by Heidi Pelletier. Motion passes 4-0.
