I. Meeting called to order at 6:00 P.M.

II. <u>Minutes for approval:</u>

A motion was made by E. Philla to approve the minutes of November 27, 2018. E. Bouley seconded the motion. Motion passed 5-0.

IV. Appointments:

Jack Sidar – Buzzards Bay Coalition was present to discuss the Baseline Documentation Report. Conservation restrictions are on 4 properties along the Acushnet River. The Keating location has public access, the Riverside, Coelho and Walega properties do not have public access yet. The Commission reviewed the plan and pictures electronically online.

V. Old Business:

NOI - D.P.M. Development / Off North Side of Blaise Drive (SE001-530) — A Notice of Intent was filed by D.P.M. Development Corp. for property located on the north side of Blaise Drive, Map 12, Lots 18A,1, 11C and 11D. The applicant proposes to construct a 17 lot subdivision off the north side of Blaise Drive within the buffer zone of a bordering vegetated wetland. The applicant is represented by Jeff Tallman of SITEC, Inc. Plan name is "Subdivision plan of Moniz Estates". Plan date is July 26, 2018.

Agent Kelly received a call from Jeff Tallman to request a continuance to next meeting. E. Philla made a motion to continue to the next meeting. P. Valente seconded the motion. Motion passed 5-0.

VI. New Business:

RDA – Long Plain Cranberry Nominee Trust, Susan Amaral Trustee / Adjacent to 28 Lake Street – A Request for Determination of Applicability was filed by Long Plain Cranberry Nominee Trust, Susan Amaral Trustee for property located adjacent to 28 Lake Street, Acushnet, MA - Map 19 Lots 38A and 38E. The applicant requests whether the boundaries of resource area(s) depicted on plans or maps are accurately delineated. The applicant is represented by Prime Engineering, Inc. Plan name is "Wetland Bog Delineation Plan". Plan date is December 13, 2018.

Julie Goodwin from Prime Engineering was present to discuss this project. Commission members did a site visit on Saturday. 1 part of the bogs are naturally occurring, the other parts are new. Julie provided the Commission with a bog report. Agent Kelly commented on how there are dramatic differences in the soils. E. Philla would like Ms. Goodwin and the Commission to keep in touch regarding the next filing, Everett would like Commission members to walk the property again in the spring or before next phase of planning begins. E. Bouley made a motion to issue a positive determination. H. Pelletier seconded the motion. Motion passed 5-0.

Agent Updates:

Agent Kelly had the following updates:

- 2019 Filing deadline schedule was presented to the Commission. They voted to accept it.
- Peckham Road Arruda Agent Kelly received a call from Jamie of Zenith Consulting Engineers asking to lift the enforcement order. Commission would like to do a site visit on the 19th of January before they lift it.
- Community Preservation Applications are available and the deadline for submittal is January 29, 2019.
