NOI - D.P.M. Development / Off North Side of Blaise Drive (SE001-530) — A Notice of Intent was filed by D.P.M. Development Corp. for property located at the north side of Blaise Drive, Map 12, Lots 18A.1, 11C and 11D. The applicant proposes to construct a 17 lot subdivision off the north side of Blaise Drive within the buffer zone of a bordering vegetated wetland. The applicant is represented by SITEC, Inc. Plan name is "Subdivision plan of Moniz Estates". Plan date is July 26, 2018.

Agent Kelly received a call to request to continue to the next meeting due to the Planning Board meeting scheduled for December 13th. E. Philla made a motion to continue to the next meeting date. H. Pelletier seconded the motion. Motion passed 4-0.

VI. New Business:

RDA – Andrew Corrigan / Main Street – A Request for Determination of Applicability was filed by Andrew Corrigan for property located at Main Street, Acushnet, MA., Map 21 Lot 14C. The applicant proposes to construct a single family house with an on-site septic system, public water supply, grading and landscaping within the 100-foot buffer zone to a bordering vegetated wetland.

Alan Ewing from Alan Ewing Engineering, Inc. was present to discuss this project. Commission members did a site visit on Saturday. Mr. Ewing stated the wetlands have been flagged and the percolation test has been completed. A silt fence will be used. A retaining wall will be installed to reduce the amount of fill needed. Agent Kelly noticed that some of the flags were broken off at the knots, Mr. Corrigan has hung new flags. H. Pelletier made a motion to issue a negative determination and also have Agent Kelly verify the flags are in place. E. Philla seconded the motion. Motion passed 4-0.

ANRAD – TJA Clean Energy, LLC / 540R Main Street – An Abbreviated Notice of Resource Area Delineation was filed by Atlantic Design Engineers, Inc. for TJA Clean Energy, LLC for property located at 540R Main Street, Map 11, Lot 10. The applicant is represented by Atlantic Design Engineers, Inc. Ref. "Wetland location plan for 540R Main Street" dated October 25, 2018.

Agent Kelly received a call from the applicant requesting to withdraw this application. Chairman Rocha read aloud the advertisement for the record.
