Extension of an Order of Conditions – Koska / Deep Brook Estates SE 001-0523 A

Request for a three-year Extension of an Order of Conditions was filed for John Koska for property known as Deep Brook Estates, Map 17, Lots 66 – 84 and Map 18, Lots 12 R –U, 18 and 18 F –G. The applicant is represented by Robert Rogers of G.A.F. Engineering, Inc. Mr. Rogers submitted a letter to the Commission for the Extension. Mr. Rogers mentioned the property is in litigation and no work has commenced. Mr. Rogers is requesting a three-year Extension. E. Philla made a motion to issue a three-year Extension to the Order of Conditions. H. Pelletier seconded the motion. Motion passed 5-0.

Meeting adjourned at 6:13 P.M.






