A motion was made by R. Rezendes to approve the minutes of November 10, 2020. P. Valente seconded the motion. Motion passed 6-0.

VII. <u>Discussion:</u>

Wetlands By-Law Paul Valente is Chairman of the Wetlands By-Law Subcommittee. Members are as follows: Ryan Rezendes, Robert Rocha and Richard Pimentel. Agent Kelly sent an email regarding the definition of a river – intermittent vs. perennial streams for all to read. Some members did not have a chance to review it, R. Rocha suggested that everyone read it first. R. Rocha asked sub-committee Chairman Valente if he would be drafting the Standards discussed? Chairman Valente said he would have a draft ready for the next meeting, topics include changes to the no activity zone and pool discharging/dry well use. End of Wetlands By-Law Subcommittee discussion.

P.J. Keating Company Agent Kelly sent out an Enforcement Order regarding P.J. Keating Company to the members earlier today. Chairman Rocha read the E.O. aloud. R. Rezendes spoke about silt in the vegetation area and recent dredging and work on the outfall pipe. Chairman Rocha said EPA has been experiencing delays in response times due to Covid. E. Philla noticed a spelling error, Merilee to correct before signing. Chairman Rocha did a roll call vote: R. Pimentel – Yes; P. Valente – Yes; R. Rezendes – Yes, E. Philla – Yes, E. Bouley – Yes and Chairman Rocha – Yes. Motion passed 6-0.

Hunting on Conservation Land R. Rezendes emailed the members a document to review regarding hunting on Conservation land. Chairman Rocha shared the document on Zoom. R. Rezendes called some surrounding Towns to speak with the Town Officials regarding this subject. Rochester follows Massachusetts State Laws on hunting regulations and set backs. They allow hunting but do not advertise it. Mattapoisett follows Massachusetts guidelines, no regulations on file. Fairhaven has no regulations either. Agent Kelly said approximately 2 years ago that this was a conflict regarding hikers and geocachers. There are no minutes from past meetings to review on file with the Town Clerk. P. Valente made a comment that hunting is allowed on these Town owned areas. R. Rezendes said that Agent Kelly said that no hunting signs are posted on the properties, so she said you can't hunt because the former Town Administrator said no hunting. Chairman Rocha said this document will make things clearer. E. Philla would like to approach the Board of Health regarding the ticks and the disease they carry. Also, get the Board of Selectmen involved. E. Bouley suggested all members in support of this document meet with the Board of Selectmen. Motion was made for the Conservation Commission to move forward with language that clarifies the process of hunting on conservation land. R. Rezendes made that a motion. E. Bouley seconded the motion. Chairman Rocha did a roll call vote: R. Rezendes – Yes, R. Pimentel – Yes; P. Valente – Yes; E. Philla – Yes; E. Bouley; - Yes; Chairman Rocha – Yes. Motion passed. 6-0.

VIII. <u>Agent Updates</u>: P. Valente would like to inquire about a six lot parcel on 301 Perry Hill Road, driveway is now being constructed, any filing for this work? Agent Kelly to research. P. Valente would like this placed on file.

R. Rezendes mentioned MACC has released a new guidebook on buffer zones.

Meeting adjourned at 7:05 P.M.
