# Meeting called to order at 6:00 p.m. held via Zoom.

Workshop: Discussion regarding P.J. Keating Co., 72 South Main Street. Agent Hannon had a slideshow presentation. Video clips from prior meetings along with photos were shown. Discussions included silt pile stabilization, photo of rutting was shown. Image of truck was shown to depict dust; the middle of the road was watered but the sides were not. Clip of meeting was played regarding the Flexterra application. Agent Hannon also showed a picture from 2019 and a current 2021 picture of the silt pile. A current picture of Basin 1C was also shown. The

slope degree was discussed, the silt fence is down, Mike Warner was going to work on fixing the erosion control. Agent Hannon shared a photo of the silt fencing down. The date certain was not placed in the order of conditions. When the NOI was submitted, the stormwater regulation did apply but the stormwater box was not checked. Agent Hannon mentioned he would like to issue an enforcement order and then place it on the next agenda for ratification. Chairman Rocha asked if the Commission had any questions or comments. None. Attorney Blake no comments. Attorney Luke Legere commented on how it was hard to follow the video clips without the dates, this has been a lengthy process for the issuance of the order of conditions.   updated to correctly reflect the change. The Stormwater regulation will need new
  language and need to be advertised.
