**b.** Robinson Road solar project screening. Since construction has begun an abutter came forward questioning the project screening. The abutter has notified the planning board that they will be in attendance at this meeting to discuss the project screening.

Kathy Massey comes forward and says she wouldn't be here if they were notified. The Chairman states he was not on the Board in 2021 when this first started. The Chairman states before this gets a final approval, he will have a final inspection done by the Building Inspector. He will make sure the trees are adequate. The Chairman also states he will make sure the trees that do get put in are the 25 ft trees. Another resident comes forward David of 50 Cushing I.n. David brings up all the other solar fields in town, they are set way back. The ones that are up against the road, there is a privacy fence around them so you're not staring at the structure. David asked is there any privacy that can go around the hard structure. Kathy and David are asking for a privacy fence along their side. Chairman states he is going to have Paul look into the files to see if the abutters Kathy and David received a green card. Chairman states whether he can go back to the proponent and asked them to change the fencing on the back half, since this was already approved. David asked if they refused, can he put up a fence? Chairman Francois has committed to looking into the notification of abutter issue and will approach the proponent on options for screening on the back half of the project.
