- 1. Call to Order.
- 2. All recited the Pledge of Allegiance.
- 3. Approval of minutes, payrolls and warrants:
- a. Motion was made by Mrs. Downing and seconded by Mr. Sumner to approve the minutes of April 24, 2018. Mr. DeTerra abstained. The committee agreed.
- b. Motion was made by Mr. Sumner and seconded by Mrs. Downing to approve all payrolls and warrants. The committee unanimously agreed.

- 5. Old Business:
- a. FY18-19 School Calendar. Mr. Shea informed the committee that Dr. Bailey had reviewed the district's calendar and made some minor changes to the professional development dates. Discussion ensued.
- 6. New Business:
- a. First Grade Update, Jared Alves. Mr. Alves informed the committee of all the activities and programs that are happening in the first grade.
- b. Personnel Matters, Mr. Shea. Mr. Shea informed the committee of the recent personnel changes in the district.
- c. School Choice, Mr. Shea. Earlier in the evening the public school choice hearing was held. Mr. Shea recommended we **not** participate. A discussion took place as to how school choice is determined. Discussion ensued.
