Old Business:

NOI – GDC Development / Lot 5, Quaker Lane – A Notice of Intent was filed by GDC Development, for property located at Lot 5, Quaker Lane, Map 5, Lot 6C. The applicant proposes to construct a single family dwelling, along with associated grading and utilities. A portion of the work falls within the buffer zone of a bordering vegetated wetland. The applicant is represented by SITEC Civil and Environmental Engineering plan dated 12-30-15.

ANRAD – EVERSOURCE ENERGY/ 143 PECKHAM ROAD SE001-0505 – An Abbreviated Notice of Resource Area Delineation was filed by Eversource Energy for property located on 143 Peckham Road, Map 2, Lots 1,2,3,3AE,3C,3D,3E,3F,3G,3Z,5,6,10,and 12A. The applicant is represented by TRC Environmental Corp. Ref. "Wetland Delineation Plan" dated November, 2015.

New Business:

RDA – **Kingsley** / **213 Hathaway Road** – A Request for Determination of Applicability was filed by Kaitlyn Kingsley for property located at 213 Hathaway Road, Map 12, Lot 17Z. The applicant proposes to install an above-ground swimming pool within the 100 foot buffer zone of a bordering vegetated wetland.

COC – **Boisvert / 21 Green Meadow Drive** – A Request for Certificate of Completion was filed by Alan Ewing Engineering, Inc., for property located at 21 Green Meadow Drive, Map 14, Lot 7G (DEP# SE001-0255). The applicant proposed the construction of a single family home within the 100 foot butter zone of a bordering vegetated wetland, plan dated3/20/00.
