**COC – Koestner / 78 Peckham Road (SE001-0509)** – A Request for a Certificate of Compliance was filed by Richard Koestner for property located at 78 Peckham Road in Acushnet, Map 16, Lot 1K. The applicant proposed an upgrade of a residential septic system within the 100 foot buffer zone to a bordering vegetated wetland. The applicant is represented by Foresight Engineering, Inc., plan dated 10/10/16.
