Old Business:

AMENDED OOC – Menard / Pageotte St. (SE001-0512) – A Notice of Intent was filed by David Menard for property located at Pageotte Street, Map 15, Lot(s) 222 & 241. The applicant proposes to construct a new single-family residence with associated driveway and septic, within the 100 foot buffer zone to a bordering vegetated wetland, the septic system is being moved by approximately two (2) feet. Plan name "Sewage Disposal Plan of Land at Pageotte Street in Acushnet, MA". Revised plan dated 2/22/17.

New Business:

COC – **Castonguay Family Living Trust** / **18 Carol Street** (**SE001-0423**) – A request for a Certificate of Compliance was filed by Susanna (Bolger) Sylvia for property located at 18 Carol Street, Map 4, Lot(s) 4. The applicant proposed to upgrade the existing cesspool to Title 5 standards by installing a new 1,500 gallon septic tank, 1,000 gallon pump chamber and raised leaching area. NOI – Town of Acushnet / Lake Street R.O.W. (SE001-0514) – A Notice of Intent was filed by Dan Menard for property located at Lake Street, Map 4, Lot(s) 49 & R.O.W. The applicant proposes to add sidewalks and guard rails to existing road (Lake St.), within the 100 foot buffer zone to a bordering vegetated wetland.
