Section \_\_\_\_ Marijuana Establishments Prohibited

Consistent with G.L. c94G, §3(a)(2), all types of non-medical “marijuana establishments” as defined in G.L. c94G, §1, including marijuana cultivators, independent testing laboratories, marijuana product manufacturers, marijuana retailers or any other type of licensed marijuana-related businesses, shall be prohibited within the Town of Acushnet.

This Section shall be effective upon approval by the Attorney General having previously been approved by the voters at the Town Election of April 2, 2018.
