RDA – Forsblom/ 18 Davis Farm Lane – A Request for Determination of Applicability was filed by Keith Forsblom for property located on 18 Davis Farm Lane, Map 6, Lot 4H. The applicant proposes to clear property in rear of home, and possible re-construct the retaining wall, within the 100-foot buffer zone of a bordering vegetated wetland. The applicant would like to know whether the work depicted is subject to the Wetlands Protection Act.

RDA – **Ciano**/ **52 Morse's Lane** – A Request for Determination of Applicability was filed by Christopher & Johnelle G. Ciano for property located on 52 Morse's Lane, Map 17, Lot 24.
