## New Business:

**NOI – Eversource Energy / 143 Peckham Road (SE001-0517)** – A Notice of Intent was filed by Eversource Energy for property located at 143 Peckham Road, Map 2, Lot(s) 3C & 3D. The applicant proposes to improve the existing access road around the existing LNG facility through minor grading and placement of a new crushed gravel road surface. A portion of the work is within the 100 foot buffer zone to a bordering vegetated wetland. The applicant is represented by Tighe & Bond. Plan name "Eversource Energy LNG Facility Acushnet, Massachusetts Access Road Upgrades. Plan dated November 2016.

**RDA** – **Rose / 74 Nestles Lane** – A Request for Determination of Applicability was filed by Phil & Debbie Rose for property located at 74 Nestles Lane, Map 2, Lot(s) 3Y. The applicant proposes to raze the existing dwelling and construct a new single family house and garage with associated grading within the 100-foot buffer zone to a bordering vegetated wetland. The applicant would like to know whether the work depicted on plan(s) referenced is subject to the Wetlands Protection Act. The applicant is represented by Grady Consulting, LLC. Plan name is "Site Plan". Revised plan dated May 11, 2017.

**NOI – Dubois / 100 Perry Hill Road (SE001-0518)** – A Notice of Intent was filed by Russell Dubois for property located at 100 Perry Hill Road, Map 9, Lot(s) 18. The applicant proposes to construct a 28' by 30' garage as an accessory structure to the existing single family dwelling within the 200-foot riverfront area to a stream. Plan name "Sketch to Accompany Notice of Intent, Lot 9 Perry Hill Road, Acushnet, Massachusetts". Plan dated 5-11-17.

**RDA** – **Murray** / **77 Lambert Street** – A Request for Determination of Applicability was filed by Kevin Murray for property located at 77 Lambert Street, Map 18, Lot(s) 199. The applicant proposes to clear and grade and re-landscape the property located within the 100 foot buffer zone to a bordering vegetated wetland. The applicant would like to know whether the work depicted on plan(s) referenced is subject to the Wetlands Protection Act. Plan name is "Septic System for Map 18, Lot 199, Hindle and Lambert Streets, Acushnet". Plan dated May 1988.
