# REVISED POSTING - NON-MEDICAL MARIJUANA ESTABLISHMENTS PROHIBITION

Notice of Planning Board Hearing Relative to Proposed Zoning By-Law Amendments Pursuant to M.G.L. c. 40A, § 5

The Planning Board of the Town of **Acushnet** will hold a public hearing to discuss proposed amendments to the town's zoning by-laws. The public hearing will be held as follows:

To see if the Town will vote to amend the Zoning Bylaw of the Town of Acushnet by amending Section \_\_\_\_\_, to add: Consistent with M.G.L. c.94G, §3(a)(2), all types of non-medical "marijuana establishments" as defined in M.G.L.c.94G, §1, including marijuana cultivators, independent testing laboratories, marijuana product manufacturers, marijuana retailers or any other type of licensed marijuana-related businesses, shall be prohibited within the Town of Acushnet.

Or take any action relative thereto.

If the Town votes to allow non-medical marijuana establishments....

### **Zoning Bylaw Warrant Article**

To see if the Town will vote to amend Town of Acushnet Bylaws, Zoning Article VIII, Section 3.3., to allow non-medical marijuana establishments as a permitted use by special permit **in I-1 and I-2 Districts.** Consistent with G.L. c.94G, §3(a)(2), all types of non-medical "marijuana establishments" shall be defined as marijuana cultivators, independent testing laboratories, marijuana product manufacturers, and licensed marijuana retailers Or take any action relative thereto.

If the Town votes to prohibit non-medical marijuana establishments, this Bylaw amendment can be tabled.
